EDUCATIONAL PACKAGES RENTAL REGULATIONS

1. Educational packages can be borrowed at the Information Point at the entrance to the Mużakowski Park in Łęknica, ul. Hutnicza 19.

2. You are requested to read these regulations before you borrow educational packages.

3. Borrowing educational packages is tantamount to the fact that the borrower has got familiar with the content of these regulations and agrees to all provisions contained therein.

4. Educational packages are the property of the National Heritage Institute with its registered office in Warsaw (00-924), ul. Kopernika 36/40, a public cultural institution, entered into the register of cultural institutions kept by the Minister of Culture and Cultural Heritage under the number RIK 140/2024, VAT payer with the NIP number: 525-300-65-50, REGON: 528844396 (hereinafter "NID") and can be used only within the area of the Mużakowski Park.

5. Educational packages can be borrowed between 9:00 a.m. and 4:00 p.m. Packages must be returned by 5:00 p.m. (point closing time).

6. In order to borrow educational packages, the borrower (hereinafter referred to as the "Borrower") should:

- a) pay a refundable cash deposit of PLN 50 or EUR 15 at the Information Point in the Mużakowski Park in Łęknica;
- b) fill in the educational package rental form ("Form");
- c) show to the lenders an identity document at the Information Point in order to enable verification of the personal data provided by the Borrower in the Form in accordance with point b) above. The person borrowing the educational package and filling in the Form provides their personal data consciously and voluntarily in order to use the educational package, i.e. to perform the educational package lending agreement. At the same time, in the event of potential damage in the form of damage to the educational package, the personal data of the borrower may be processed within the scope of handling the claims that have arisen;
 d) check the status of the educational package before collecting it at the Information Point.

7. The Borrower is responsible for any damage to the educational package. The Borrower shall immediately report any damage to the person at the Information Point, who will note such a case in the Form.

8. To receive a refund of the deposit, the educational package must be returned to the Information Point. After checking whether the educational package has been returned intact, the person at the Information Point will return the deposit to the Borrower.

9. By signing the Form, the Borrower accepts the provisions of these Regulations in their entirety and undertakes to comply with them.

10. In the event of destruction of the educational package or failure to return it to the Information Point, the Borrower will not receive a refundable deposit for borrowing the educational package.

12. In matters not regulated by these Regulations, the provisions of the Civil Code shall apply.
